ORDER OF FORFEITURE  
PURSUANT TO 21 U.S.C. § 881


THIS MATTER came before the court on Monday, December 29, 2003,  
on an order to show cause why the relief prayed for by plaintiff; *i.e.* that the  
automobile described above should be forfeited to the United States pursuant to  
21 U.S.C. § 881(a)(4), should not be granted. Plaintiff appeared by and through  
Assistant U.S. Attorney Gregory Baka; claimant WANG, Yang appeared by  
and through his attorney, G. Anthony Long.

1 THE COURT, having heard and considered the evidence presented, finds  
2 that plaintiff showed by a preponderance of the evidence that the automobile  
3 described as a 1998 Kia "Sephia," VIN KNAFB1219W5740266, was properly  
4 forfeitable to the United States pursuant to 21 U.S.C. § 881(a)(4) because it had  
5 been used to facilitate the sale of a controlled substance, to wit, methampheta-  
6 mine hydrochloride, also known as "ice," on December 12, 2002. Specifically,  
7 the court found credible the testimony of US/CNMI Drug Task Force Agent  
8 Ray Renguul that he had purchased a quantity of methamphetamine  
9 hydrochloride from the registered owner of the vehicle, WANG, Yang, on  
10 December 12, 2002. The transaction occurred in the parking lot of Winchell's  
11 Donuts, Garapan, Saipan. Agent Renguul testified that Wang had shown him  
12 that he was listed as the registered owner of the subject vehicle so that Renguul  
13 would know that he could rely on the car as "security" while Wang took the  
14 "buy money" from Renguul and went on foot to retrieve the methamphetamine  
15 from a nearby location. Renguul sat in the subject vehicle until Wang returned  
16 with the methamphetamine hydrochloride.

24 Claimant Wang presented no credible evidence in opposition to the  
25 testimony of Agent Renguul that the vehicle was not subject to forfeiture.

1 FOR THE FOREGOING REASONS, it is ordered that the 1998 Kia  
2 "Sephia," VIN KNAFB1219W5740266, is forfeited to the United States pursuant  
3 to 21 U.S.C. § 881(a)(4) because it was used to facilitate the sale of a controlled  
4 substance.
