TRANSCRIPT FEE SCHEDULE WITH
NAME CHANGES TO TRANSCRIPTS
CATEGORIES

To keep pace with inflation, the Judicial Conference at its September 2022 session approved an increase of roughly 10 percent per year to the maximum per page and transcript copy rates for Fiscal Years 2024 and 2025. During its September 2023 session, the Judicial Conference approved changes to transcript category names to clarify delivery timing. This Court hereby adopts the attached Transcript Fee Schedule with the initial fee increase taking effect on October 1, 2023. This General Order supersedes all previous general orders regarding transcript fee schedules and rates. **SO ORDERED** this 29th day of September, 2023.
