2022 LAW DAY THEME

Legislation, court rulings, amendments, lawyers, and "we the people" have built upon those original words across generations to attempt to make the "more perfect Union" more real.

Defining and refining those words of the Constitution might be our oldest national tradition, and how each of us works—together—toward a more perfect Union.

ABOUT THE CONTEST

- The 2022 Law Day Photo Contest is open to all public and private school students in the CNMI in Grades 6-12.
- Contestants must register to enter. Registration and entries must be submitted by May 27, 2022.
- The photos should reflect the prompt "What role does the Constitution play in times of change?"
- Students must include a brief description on how their photo represents the theme with no more than 150 words. Photos inside the courthouse facility are not allowed.
- Photos must be a student's own original photo.
- Photos will be judged according to its originality, creativity, and how well the photo represents the theme.
- Winners will be announced the first week of June 2022. Cash prizes and certificates will be presented to winners.

2022 Law Day Photo Contest Official Rules

- 1. **Who May Enter:** The competition is open to students enrolled in public and private middle schools and high schools (Grades 6-12). Children of federal judges, chambers staff, and employees of federal court offices are not eligible to participate.
- 2. **Contest Duration:** The contest begins on May 1, 2022 and the last day to enter is May 27, 2022.
- 3. **Contest Theme:** The photos should reflect the 2022 theme and reflect the prompt "What role does the Constitution play in times of change?" Students must include a brief description on how their photo represents the theme with no more than 150 words. - 4. Photos inside the courthouse facility are not permitted for security reasons and pursuant to General Order 95-00002.
- 5. **Limit:** Only <u>one entry of an original recent photo per student</u> will be accepted. Entries may not have been previously published in any medium, and the photo must be taken on or after Apr 28, 2022.
- 6. Format: One image or collage, color or black and white photographs will be considered.
- 7. **Submission:** The photo may be submitted using the online entry form posted on our court website at https://www.nmid.uscourts.gov. The entry form must be fully completed by the student and their parents or guardians. Please upload the photo in JPEG or PNG format by May 27th, 2022. If there are any issues using the online entry form, please contact Daniel Brown at 237-1205 or via email at daniel-brown@nmid.uscourts.gov to request for manual entry form.
- 8. By entering, the student gives the US District Court for the Northern Mariana Islands the right to reproduce material submitted in any medium without time, use, or territorial limitation as long as it is for non-commercial purposes.
- 9. Photos will be judged on originality, creativity, and how well the photo represents the theme.
- 10. <u>All entries must be submitted no later than 5 p.m. on May 27, 2022</u>. Students should make their submissions before this deadline to be considered.
- 11. Cash Prizes and awards: Cash Prizes and award certificates will be given to the top 3 winners for middle school/top 3 winners for high school and will announced by the first week of June 2022. 1st Place winners will receive \$75.00. 2nd Place winners will receive \$50.00. 3rd Place winners will receive \$30.00
