

H-1B VISA

H-1B Visa is for professionals such as

- •Teachers in all the private schools
- Doctors
- Medical Professionals
- Accountants at CPA firms
- Architects and engineers at professional architectural and engineering firms
- Architects, engineers and other similar jobs at construction firms
- Engineers and systems analysts at telecommunications companies and data processing businesses
- Data administrators and related jobs at insurance agencies

CAP

•Numerical of 85,000. Guam and CNMI Cap exemption expires December 31, 2019.

Enforcement

- Enforcement efforts are increasing
- •Site visits are more common
- Penalties for non compliance are increasing

H-2B VISA

Eligible Countries Philippines, Taiwan, Korea, Japan, Thailand, Etc.

H-2B Visa is for temporary skilled labor

Skilled labor must have at least 2 years of experience Common in the construction business

Temporary Need

- One time occurrence (3 Years)
- Seasonal Need (9 Months)
- Peakload Need (9 Months)
- Intermittent Need (9 Months)

Procedures of applying for H-2B Visa

- Prevailing Wage Determination (USDOL)
- SWA Recruiting US workers (CNMI DOL)
- USCIS Petitions
- Consular Processing
- POEA Clearance (the Philippines)

ONE TIME OCCURRENCE:

The law requires a Petitioner to show one of the following to establish a temporary need based on a "one-time occurrence"

- The Petitioner has not employed workers to perform the services or labor in the past, and the petitioner will not need workers to perform in the future; or
- The Petitioner has an employment situation that otherwise permanent, but a temporary event short duration has created a need for temporary workers. See 8 CFR 214.2 (h)(6)(ii)(B)(1)

PEAKLOAD NEED:

To establish a peakload need, the law requires a petitioner to "establish that it regularly employs permanent workers to perform the services or labor at the place of employment and that it needs to supplement its permanent staff at the place of employment on a temporary basis due to a seasonal or short-term demand and that the temporary additions to staff will not become a part of the petitioner's regular operation." (Emphasis added.) See 8 CFR 214.2(h)(6)(ii)(B)(3).

• It is clear from the regulation that a peakload need must be of a limited duration. That does not mean that a peakload need may not recur on a periodic basis.

L VISA (INTRA COMPANY TRANSFER)

Qualifying relationship (parents, branch, subsidiary, affiliate)

Managerial or executive responsibilities for more than one year in the past three years (L-1A) abroad

Functional Manager, <u>Matter of Z-A-, Inc.</u>, Adopted Decision 2016-02 (AAO Apr.14, 2016

Blanket L allows large companies (\$25 million per year in sales) to prequalify and get expedited treatment for L visa applications

Recent anti L-1 visa fraud program means that USCIS requests more documentation

L-1 telephone contacts and site visit are becoming more common
